NYSB5 Renewal Grant

FUNDING AMOUNT:

\$13.4 million per year for 3 years

2020-2022 = \$40.2 million

GOALS:

- Strengthening and building new partnerships
- Coordinating systems and improving transitions
 - Expanding parent choice and knowledge
- Promoting equity with a focus on vulnerable populations*





^{*}Vulnerable Children: Children who are: (1) members of minority/ethnic groups; (2) living in low-income households; (3) homeless as defined by McKinney-Vento; (4) receiving EI or special education services under Part B or Part C of IDEA; (5) living in rural communities; (6) living in multi-language households and/or (7) immigrants or refugees.



Expected Outcomes

All young children are healthy, learning and thriving in families that are supported by a full complement of services and resources essential for successful development by:

- Institutionalizing parent voice in early childhood policy making through the creation of a Parent Advisory Council and support parent engagement and choice through sharing of information.
- Aligning and strengthening early childhood interdisciplinary professional development and expanding the Aspire Registry.
- Expanding access to high-quality programs by increased participation in QUALITYstarsNY and developing cross sector indicators of quality that are easily accessible for parents.
- Using a continuous quality improvement framework to implement comprehensive early childhood activities that are specific, measurable, attainable, relevant and timely (SMART).
- Identifying strategies to maximize funding to ensure that children are developmentally on track for kindergarten.






